

Scentwork UK Guidelines for Level 4 Trials

Please be aware that it is the competitor's responsibility to read and understand these guidelines and to draw the attention of the judge and/or trial manager to any potential issues that may arise regarding any deductions that may be awarded.

The Test

The Test involves four timed searches in four separate search areas. Two areas will be interior and two will be exterior. The trial manager and judge(s) to liaise as to who will bring exterior, perimeter or bags, boxes, container items for adding to areas to be searched.

Interior searches:

1. 'Tables Chairs & Perimeter' ('TCPI') 2x scented article (5 mins permitted)

The test will be conducted indoors.

The dog to find two scented articles hidden amongst 8 chairs, 2-4 tables and around the perimeter:

1. Both on different tables, or
2. Both on different chairs, or
3. Both on two separate items that are placed around the perimeter, or
4. One on each of any two of the above three options.

NB. Scented articles will NOT be hidden in fixtures and fittings of the 'TCPI' search at level 4. The 'TCPI' search MUST take place before the 'BBC&P' search at level 4.

The room should preferably be free from other room clutter which is not part of the test. The tables and chairs can be arranged in any pattern.

Two different distraction scents will be hidden within each search area.

Distraction scents will be any two of the following:

- Blank unscented cardboard (1cm x 1cm - 2cm x 2cm)
- Blank unscented cotton/fleece/velcro (1cm x 1cm - 2cm x 2cm)
- Dog odour Eg. Used dog towelling/bedding or equipment such as a lead/harness.

Handlers have only two opportunities to call an alert. Handlers who give a first wrong alert will continue the search but will be asked to 'stop' when a second alert is called whether the call is correct or incorrect.

The clock will not be stopped if a correct alert has been called first. The located item will not be removed from the search area and the dog & handler will continue to search for the second scented article. The handler and dog may leave the search area to reward if they wish to do so but time will run continuously until the second alert has been called (whether correctly or not) or when full time has been reached.

2. 'Bags, boxes containers and Perimeter' ('BBC&P'): 2x scented articles (5 mins permitted)

The test will be conducted indoors. The dog to find two scented articles hidden amongst 10-15 items and the perimeter:

1. One on a bag or piece of luggage/cardboard box/container and
2. One in any fixtures and fittings of the perimeter.

NB. The 'BBC&P' search MUST take place after the 'TCPI' search at level 4.

The judge will confirm which fixtures and fittings are included and the scented article must be concealed where it will be considered a surface hide. (See definition notes below.)

The scented article should be located no higher than 80cm. Height will be determined by the size and physical capabilities of the dogs at the trial.

The room should preferably be as free from other room clutter as possible. There should be a mixture of containers which may include cardboard boxes, luggage, bags, hard plastic & wooden containers and any other suitable items. The luggage shouldn't be padded with anything other than newspaper, brown paper or bubble wrap.

The scented articles should be easily accessible to the dog, for example around handle areas and pockets on luggage and underneath the flaps on a single box. The boxes can either be 'open end' up or 'overturned' and the scented articles should be placed just under the flap or just in the seam.

Two different distraction scents will be hidden within each search area.

Distraction scents will be any two of the following:

- Blank unscented cardboard (1cm x 1cm - 2cm x 2cm)
- Blank unscented cotton/fleece/velcro (1cm x 1cm - 2cm x 2cm)
- Dog odour Eg. Used dog towelling/bedding or equipment such as a lead/harness.

Handlers who give a first wrong alert will continue the search but will be asked to 'stop' if a second wrong alert is called.

When the handler calls a correct alert, the judge will confirm, and the clock will not be stopped. The item containing the scented article will not be removed and the handler and dog team should continue their search. The handler may choose to leave the search area to reward the dog, but the clock will continue to run until the second alert is given or time has run out.

Exterior searches:

3. 'Exterior items' ('ExIt'): 2x scented articles (5 mins permitted)

The test must be conducted outdoors. During the 'ExIt' search the dog to find two scented articles amongst 10-15 medium to large items in a 'marked out' area approximately 6m x 6m up to 8m x 8m in size:

1. One on any of the items that are placed within the search area, and
2. One on any other item that is placed within the search area but not on items that are adjacent to each other.

The area can be of any shape.

The ground surface can consist of materials such as grass, gravel, tarmac, artificial grass/fabric.

If it is to take place in a public area it is recommended that the area is fenced off using plastic webbing or something similar. None of the items will contain materials such as litter, rope, hessian packaging or anything else that could become a 'distraction scent' to the dog.

Two different distraction scents will be hidden within each search area. Distraction scents will be any two of the following:

- Blank unscented cardboard (1cm x 1cm - 2cm x 2cm)
- Blank unscented cotton/fleece/velcro (1cm x 1cm - 2cm x 2cm)
- Dog odour E.g. Used dog towelling/bedding or equipment such as a lead/harness

Handlers have only two opportunities to call an alert. Handlers who give a first wrong alert will continue the search but will be asked to 'stop' when a second alert is called whether the call is correct or incorrect.

The clock will not be stopped if a correct alert has been called first. The located item will not be removed from the search area and the dog & handler will continue to search for the second scented article. The handler and dog may leave the search area to reward if they wish to do so but time will run continuously until the second alert has been called (whether correctly or not) or when full time has been reached.

If a dog is interfered with by another dog entering the search area then the stopwatch will be paused and will restart when the team is ready. The judge will decide if the team is allowed a re-run.

4. 'Vehicle or wall' ('VW'): 2x scented article (5 minutes permitted)

To find two scented articles on the exterior of 3 vehicles (or on a wall or combination of both): During the 'VW' search the two scented articles will be hidden:

1. Two on any vehicles or
2. One on a wall and one on a vehicle or
3. Both on a wall.

If two vehicles, wall should be 10m in length If one vehicle, wall should be 15m in length.

If no vehicles, wall should be 20m in length (Both hides could be on the same vehicle. If both hides are on the same vehicle or a wall they must not be closer than 1m 20cm to each other)

The vehicles need not be cleaned prior to the test but must not contain any other dogs. The vehicle must be parked in a safe area that allows the team easy access to all four sides. This could be on any type of surface or on verges. The scented article should be located no higher than 80cm. Height will be determined by the size and physical capabilities of the dogs at the trial. Any excessive scratching at the paintwork should be stopped by the judge immediately.

The outside wall can be brick, wood or any solid material. The length will be 10m, 15m or 20m depending on how many vehicles are available and may include doors, window sills, drain pipes, taps, heating vents etc. which may be used as potential hiding places (Heating vents must not be used to hide scented articles if they are in use). On a wall where there may be a lack of hiding places, additional objects may be placed at the foot of the wall. The number of items will be at the discretion of the judge.

Bases of walls must be free from sharp, uneven surfaces and not contain any harmful materials such as nettles etc.

There will be NO distraction scents on any vehicles or a wall.

Handlers have only two opportunities to call an alert. Handlers who give a first wrong alert will continue the search but will be asked to 'stop' when a second alert is called whether the call is correct or incorrect.

The clock will not be stopped if a correct alert has been called first. The handler may choose to leave the search area to reward the dog but the clock will continue to run until the second alert is called (whether correctly or not) or when time has run out.

NOTES

Target scents will be 'cloves and 'Napier 'gun oil'. See preparation in 'Definitions/Notes.

See preparation in 'Definitions/Notes.

Competitors can choose to end any search before the permitted time is up, even if the scented items have not been found. The time recorded for the search will be the time the competitor ended the search. The competitor can continue to work the other three search areas and can still pass providing 6 out of 8 scented articles have been found in total.

Marking System

The team must find 6 out of 8 scented articles to pass the overall test.

The searches can run in any order. 10 points for each scented article found 80 marks

10 points for each scented article found	80 marks
5 'Handling points' will be available per search area.	20 marks
Total Available	100 marks
Qualifying Mark	60 marks

Allocation of marks and Qualification:

Qualification Mark = 60

A minimum of 6 scented articles must be correctly identified.

10 points for the handler calling each 'alert/find' correctly.

5 handling points in each area if no deductions are made.

Maximum of 100 points available.

If the handler fails to call a correct 'alert/find' in an area, the team are still entitled to 5 handling points, providing no deductions have been made.

Permissible deductions are listed under Judge's Deductions.

Certificates of merit will be awarded to those that qualify and in addition there will be rosettes from 1st to 4th awarded to those with the highest marks. Any team that finishes outside of the top 4 with a maximum of all 8 hides found and no handling points deductions will receive a clean sweep rosette. In the event of a tie the team with the fastest time will be the winner.

Disqualification

See deduction notes below.

General Guidelines

- Owners/handlers of visually impaired dogs may wish to accompany them on a walk-through of all search areas to acclimate before the target odour is placed. Owners/handlers of dogs fitting this criteria must communicate their circumstances when booking to the Trial Organiser/Manager & in every case, before their arrival on trial day. It will be considered good practice to permit this activity. However, it remains at the discretion of individual Trial Managers and judges to do so.
- Owners/handlers of visually impaired dogs may wish to and will be permitted to give an audible signal whilst under test in search areas.
Handlers may choose to:
 - i) click fingers
 - Or tap items/objects or floor with:
 - ii) non powdered nitrile or vinyl gloves
 - iii) clean stickThis includes Tables, chairs, fixtures and fittings, interior and exterior items, vehicles and walls.
In all cases the judge must be informed of this intention and no damage or disturbance to scented article must take place.
- The team to find 6 out of 8 scented articles within four search areas using either an 'active' or 'passive' indication. See Definitions/Notes below
- Dogs can be on or off lead, can switch between on or off lead and this decision is entirely the responsibility of the handler.
- There will be a draw for each of the tests to determine the running order of the teams.
- Where necessary search areas will be clearly identified by flags, cones, tape or other identifiers.
- The hides will only be within the designated search area.
- At the start of each search the judge will tell the competitor how many scented articles are hidden in the particular search area and how much time they have.
- No items should be touched or moved by the competitor.
- Each search area will have a start point marked with a pair of cones through which the dog must pass to start the test.
- The judge will ask the handler when he/she is ready and as soon as the dog's nose passes the start markers the scribe will start the stopwatch. 10 points for each scented article found 80 marks 5 'Handling points' will be available per search area. 20 marks Total Available 100 marks Qualifying Mark 60 marks
- Handlers may choose to work the search area from any angle after the dog has crossed the designated start markers.
- The judge will ask the competitor if they want a 30 second time warning.
- The scented article should be located no higher than 80cm. Height will be determined by the size of the dogs at the trial.
- Calling the 'Alert/Find'. When the handler thinks his/her dog has found the scented article the handler should tell the judge verbally and/or by raising their hand/arm. If

the judge asks the competitor to confirm 'where' for clarification, the competitor should not send the dog in again but should show the judge by 'pointing' to with a 'verbal explanation' of where the scented article might be hidden. Marks will be lost if the competitor asks the dog to search for a second time or allows the dog to search again.

- When the handler calls a correct alert, the judge will confirm and the clock will not be stopped. The item containing the scented article will not be removed and the handler and dog team will continue. The search will end when the second alert is given or time has run out.
- The judge will tell the handler at the time if each 'alert' is correct or not.
- The handlers can carry rewards with them during the search but must not reward, other than a verbal or physical reward of praise within the search area.
- If a dog is interfered with by another dog or member of public entering the search area then the stopwatch will be paused and will restart when the team is ready. The judge will decide if the team is allowed a re-run.
- Two different distraction scents will be hidden within each search area. Distraction scents will be any two of the following:
 - Blank unscented cardboard (1cm x 1cm - 2cm x 2cm)
 - Blank unscented cotton/fleece/velcro (1cm x 1cm - 2cm x 2cm)
 - Dog odour Eg. Used dog towelling/bedding or equipment such as a lead/harness
- The competitor will be told after the search how many scented articles were found and how many deductions were lost. It is the responsibility of the competitor to point out any discrepancies at the time as marks cannot be changed from then after. The judge's decision is final.

Judge's Guidelines

- It will be considered good practice yet at the discretion of individual Trial Managers & Judges to allow dogs that are visually impaired an opportunity to walk thru search areas in order to acclimate prior to target odour being placed.
- Owners/handlers of visually impaired dogs may wish to and will be permitted to give an audible signal whilst under test in search areas. Handlers may choose to:
 - i) click fingers
 - Or tap items/objects or floor with:
 - ii) non powdered nitrile or vinyl gloves
 - iii) clean stickAny information relating to specific search areas must be relayed to and understood by individual handlers prior to the start of a test.
- The judge will hold a briefing before the tests begin and may give the handler brief feedback after each test.
- Two different distraction scents will be hidden within each search area. Distraction scents will be any two of the following:
 - Blank unscented cardboard (1cm x 1cm - 2cm x 2cm)
 - Blank unscented cotton/fleece/velcro (1cm x 1cm - 2cm x 2cm)
 - Dog odour Eg. Used dog towelling/bedding or equipment such as a lead/harness
- The judge will ask the competitor how they will let them know that their dog has found the scented article.
- The judge will ask the competitor if they want a 30 second time warning.
- When the competitor calls the 'alert' the judge will tell the competitor at the time if this is correct or not.

- Scented articles will be placed in the hide a minimum of 10 minutes before the first competitor starts.
- The scented article should be hidden from view and positioned to prevent the dog from retrieving as far as possible.
- Hides should not be readily visible but neither must they be fully enclosed. They should be placed in such a way that the scent of the article is easily accessible to the dog.
- In the vehicle or wall search if the dog is near the source of the scent, but it is not clear to the judge that the dog has communicated the exact location, the judge should ask “where?” The handler must then point or explain where they the source of scent to be. For Level 1-3 trials, the handler may indicate an area up to 6 inches, on any axis. (a vertical six inches, a horizontal six inches, or a diagonal six inches).
- The handler can indicate the source of the scented article to the judge even though the dog isn’t in that area when it is called; providing it is called before the time is up.
- The judge may stop the search in the event of fouling in the search area, extreme trashing of items, damage to vehicles, and the dog continually leaving the search area and clearly not searching. The dog and handler team will be allowed to continue to search the other search areas.
- Every effort will be made to use a ‘white dog’ prior to testing to check the scent strength and its location. When a ‘white dog’ isn’t available the first dog in the running order will complete the search, after which the judge will determine whether the search is acceptable or not. If the first dog to run encounters unforeseen difficulties, the judge can decide to adjust the search test and the dog/handler team will be allowed a re-run at the end of the class. See **White Dog** in ‘Definitions/Notes’ below.

Judge's Notes:

- Please note that the above deductions are the only deductions that can be used.
- Actual value of each deduction to be determined by the judge up to the maximum points specified in the table above.
- Once a maximum of 5.0 marks has been lost the competitor can no longer lose any further points but may continue with the search except for continuous fouling and trashing.
- Deductions are per search area and can only be deducted once per search.
- Any information specific to the particular venue should be given to competitors at Judge's Briefing or prior to teams starting searches.
- Competitors should be aware that handling of a harsh or punitive manner will result in deductions being made.

Deductions Notes:

1. Handler should be aware of potentially blocking the scent from the dog when standing between the dog and items to be searched.
2. Handler should be aware of the dog being in odour:
Marks will be lost if it is clear to the judge that the dog has detected the odour and the handler 'pulls the dog away'.
3. Marks will be lost for the following:
Dogs being worked continually on a tight lead.
Dogs being restrained and prevented from reaching the hidden odour.

NB: The judge must decipher whether it is the dog or the handler that causes the tight lead. A dog that becomes momentarily restrained by its own choice should not be penalised.

4. Marks will be lost for the handler continually asking the dog to search individual items, particularly if the dog already appears to be searching or if the communication, in the judge's opinion appears to not benefit and or hinder the dog.
5. Marks will be lost for the dog appearing to just be sniffing or wandering around the search area as opposed to searching. However dogs will not be penalised for searching the fixtures and fittings on a perimeter search even if there is no scented article present.
6. Marks will be lost for the dog continually leaving the search area and not responding to the handlers recall.
7. A Dog not quite at source:
Levels 3: A deduction of up to 0.5 marks will be lost if the dog hasn't indicated the exact location of the scented article, except those hidden on the perimeter, or in the vehicle/wall search.
On a perimeter, vehicle or wall search, if the dog indicates beyond 6" from the source no points will be awarded for the find (it will be counted as a wrong alert). If the dog is within 6" on any axis the alert will be correct. B. Re-tasking the dog to search/indicate again:
Once the alert has been called, marks will be lost for the handler re-tasking the dog, or failing to prevent the dog indicating again if the judge has asked 'Where?'
8. Marks will be lost for the handler moving or touching items without permission.
9. Trashing article - (Please read indication description in definition/notes below. Marks will be lost for any behaviour that is excessive or could potentially cause damage to the article that is scented. Behaviours not acceptable will include biting, persistent paw scratching (more than three paw contacts in succession) or throwing items around and rough handling of any non-scented items.
10. Trashing item. In the event of trashing items, deductions will be made but marks for finding the scented article will not be lost and will go towards the final total. However, in the event of continuous trashing of items the test must immediately be stopped by the judge and the handler/dog team will be eliminated from this search area (not get any marks for this search area) although the dog/handler team shall be allowed to participate in the other search tests.
11. Dog removing the scented article - If the scented article is removed and either dropped or retrieved by the dog, marks will be lost. In this event the judge must replace a fresh scented article in the exact same position before it was removed and before the next dog & handler team runs. The item does not need to be replaced unless damage occurred during the scented article removal. (see 'scented article' and 'item' in definition/notes below.)
12. Marks will be lost for feeding and rewarding in the search area, verbal rewards and physical praise are acceptable. Rewards such as food or toys may be carried but care should be taken especially in the case of food to not accidentally drop food within the search area.
13. Marks will be lost for punitive correction or harsh handling of the dog. Either through the lead or the harness and will also include harsh verbal or physical interactions that are considered detrimental to the dog.

14. Dog swallowing article

Marks will be lost if the dog attempts to or does eat or swallow the scented article.

15. Marks will be lost for scratching or other damage done to a vehicle. It may be a consideration for handlers of dogs that have a pawing indication or those that like to place feet on a vehicle to wear non-abrasive footwear.

NB More than three consecutive pawing actions will incur deductions.

16. Fouling. Up to 5 marks will be lost for dogs fouling in the search area. Repeated fouling in an area will result in elimination of that particular search area. After a fouling incident it is recommended that the search items are moved to a new search area, if possible. If the search area cannot be moved, subsequent competitors must be made aware where the fouling incident happened.

NB. If fouling occurs the stopwatch will continue to run until both dog and handler have left the search area. Dogs must not be led through the search area whilst fouling is in progress. The judge/handler should attempt to make neutral the area by removing faeces and or soaking up any urine. Adding any other scent to the fouled area to mask scent of fouling is not permitted.

THE JUDGE'S DECISION IS FINAL

Definitions/Notes:

Age of Dogs allowed to compete - Dogs aged 6 calendar months and over on the day of the trial are eligible to compete. This is the minimum age, but handlers are advised to consider the effects of; travelling, waiting around, other handler and dog teams and the activity itself. Scentwork UK trials should be; fun for all, build the confidence of the dog and the relationship between dog and handler.

Indication - The dog can indicate to the handler by expressing 'any' non- destructive behaviour. (see definition of trashing, below). Acceptable indications can include: freeze, stare, sit, down (**passive**). Lick, paw touch, nibbling, nose prod, barking (**active**).

Scented article - An article is something that is used as the carrier for the 'target odour'.

- In L1-6 the carriers should be cotton, fleece and/or Velcro. This includes material that may be made from mixed fibres such as; socks, pillowcases, t-shirts, trousers etc. Cotton wool pads are acceptable but not cotton wool balls due to likelihood of leaving fibres behind when removing.

Surface hides - A hide should not be readily visible but neither must they be fully enclosed. They should be placed in such a way that the scent of the article is easily accessible to the dog. A surface hide is when all of, or some part of the scented article is exposed to airflow and the natural environment. If none of the scented article is exposed at the point at which a dog can access it, the scented article will be considered a 'deep' hide.

Item - The term used to describe an object upon which the judge may hide the scented article e.g. box, bag, luggage and any of the exterior items.

Shells - SHELLS WILL NOT BE USED IN TIER 1, LEVELS 1-4.

White Dog - An experienced dog, not entered in the trial is allowed to do an initial 'pre-run' to help set time, assess areas of difficulty, and identify potential contamination. A 2nd 'pre- run'

can be used to test article strength and its location.
The 'white dog' is not to be handled by anyone entered in the trial.

Equipment - All dogs must wear either a collar or harness whilst under test. Slip leads or a half-check collar are permitted but handling marks will be deducted if used in a corrective manner. Dogs cannot wear a 'halti', any other head collar or retractable/flexi lead whilst working. No person shall carry out punitive correction or harsh handling of any dog at any time within the precincts of the competition.

Fails - An incorrect call of the location of the scented article(s), running out of time.

Trashing - (Please read deduction notes 9 and 10 above) Any behaviour that could or does cause damage to items and or including the scented article.
Behaviours not acceptable will include biting, persistent paw scratching (more than 3 paw contacts in succession), throwing and rough handling of any item or scented article.

In the event of continuous trashing of items the test must immediately be stopped by the judge and the handler/dog team will be eliminated from this search area (not get any marks for this search area) although the dog/handler team shall be allowed to participate in the other searches.

Fouling - (Please read deduction note 16 above) Urinating or defecating in the search area. Points will not be lost if the scented article(s) is found, however deductions will be made.

In the event of continuous fouling the test must immediately be stopped by the judge and the handler/dog team will be eliminated from this search area (not get any marks for this search area) although the dog/handler team shall be allowed to participate in the other searches.

Calling the 'Alert/Find' - Before the test begins the handler should inform the judge how she/he will call the 'Alert/Find', either verbally and/or a hand signal, when he/she thinks their dog has found a scented article.

Rewards - The competitor is allowed to reward their dog once they have passed outside of the search area or into a designated 'Reward Zone'. A designated 'Reward Zone' will be identified by the judge prior to the start of a search.

Replacement of scented articles - It will be decided by the judge to replace scented articles for the following reasons: if it has been retrieved, mouthed, or damaged in any way.

Number of dogs entered at a L2 trial - A competitor wanting to enter two dogs in the same level at a trial is permitted to do so at the trials manager's discretion and only at Levels 1 and 2.

Position of scented articles for handlers with more than one dog. - The scented articles must remain in the same location for each competitor but in the event of a person having 2 dogs in the same level, one dog will work as per draw order and the other will run last. The scented articles will be located in a different position for the second dog of the same handler. The previous scented articles and search items should be removed, and additional search items added. In the vehicle search a different vehicle should be used. When more than one handler has more than one dog another separate draw should take place.

Entering more than one Level at a trial - A dog and handler team can only enter two levels if the team has already qualified at the lower level at a previous trial.

Gaining Excellence in two different levels simultaneously

Dog/handler teams may gain excellence points in two levels at the same time.

This means that teams can attempt to achieve excellence in one level whilst also starting to gain points towards Excellence in the following level. However, when a team has qualified at more than two levels, Excellence points will only be added to the two highest Levels of qualification.

Eg. Once a team qualifies at Level 3 they will no longer be able to collect Excellence points for Level 1.

Eg. Once a team qualifies at Level 4 they will no longer be able to collect Excellence points for Level 2 and so on.

Allowing teams to run for points in two levels ensures a greater chance of being able to find, attend and compete in a level of choice.

Eligibility for entry - Open to teams that have qualified or gained Excellence (20 points) in level 3. Open to new teams that have not qualified in Level 3 as long as they run NFC. Not open to teams who have gained 20 points in level 4 or have qualified in level 6 unless they run NFC.

Bitches in Season - Bitches in season are not allowed to compete at the trial or be mated at the venue.

Unregistered Handler and Dog Teams - It is at the trial managers discretion to allow 'Unregistered teams' to enter. Unregistered teams may enter Levels 1 and 2 if they have not already qualified at these levels. If the dog, then becomes registered at a later date they will need to start in Level 1 again. No 'Qualifying' or 'Clean Sweep' points achieved during this 'unregistered' period will carry over.

Running NFC (Not for competition)

Dog and handler teams can run NFC in any level within Tier 1 providing they have qualified at Level 1. If teams have not qualified at the first level in Tier 1 they may only run NFC at Level 2.

Dog and handler teams that have qualified at Level 3 may run NFC at Tier 2 Level 5 but not Level 6

Dog and handler teams can run NFC in any level within Tier 2 providing they have qualified at Level 5. If teams have not qualified at the first level in Tier 2 they may only run NFC at Level 6.

Dog and handler teams that have qualified at Level 9 may run NFC at Tier 3 Level 11 but not Level 12

Dogs with disabilities, XL and small dogs -To inform trial manager at time of entry.

Handlers with disabilities - At time of entry handlers should inform TMs of potential issues in order to be best accommodated on the day of the trial.

Contamination - Contamination is an increasing risk as SWUK grows in popularity and as venues are used more frequently. It is the responsibility of the Trial Manager and Judge to collectively ensure to the best of their capabilities that there are no areas of contamination within the search areas and immediate vicinity. Suspect areas should be scrutinised, if possible, by a White Dog and then monitored as the trial progresses. Care should be taken when preparing a search area to use tweezers and/or gloves and pay particular attention to placement of hands once gloves have been in contact with the target scent.

After the trial is completed, all scented articles will be recovered and disposed of.

Progression - Competitors need to qualify only once at Tier 1, Tier 2, Tier 3 & Tier 4 trials before progressing to the next level. Excellence will be achieved at 20pts. Teams *must* progress to the next level once Excellence has been achieved (20 points accrued) unless they wish to enter this level as NFC.

Different Target Odour - It is at the Trials manager's discretion, (although it is not recommended) to accept entries from those competitors on different odours other than 'cloves' and 'gun oil'. If using a different scent, it is the competitor's responsibility to bring 8 scented articles of the correct size and material specification.

Preparing scented articles - It is the trial organiser's responsibility to supply 'clove' and 'gun oil' scented articles.

- To prepare **clove** scented articles, place 8/10 dried cloves in a clean, empty airtight jar. Place articles, approximately 2cm x 2cm in size on top of the dried cloves and leave at least 7 days prior to the competition. Shake the jar occasionally to ensure even, thorough scenting of the articles. **Note** that articles should not fill any jar by more than 1/4 full thus allowing complete and thorough scenting of articles within, by turning and/or shaking occasionally.
- The scented articles will be ready for use after **7 days** and for up to 4 weeks.
- The Gun oil should be prepared in the following way. The gun oil recommended for use is 'Napier gun oil'. Ensure you purchase the gun oil lubricant rather than the gun oil cleaners and sprays.
- Place 8/10 droplets of the 'gun oil' on to the top of a round cotton wool pad then place into a clean jar, oil facing up on top of articles. Alternatively suspend cotton pad above the scented articles in a shell such as a tea infuser or muslin drawstring small bag.
- Scented articles should be approximately 2cm x 2cm in size. Take care NOT to get gun oil on to individual articles as this can lead to contamination of search areas. Oil is difficult to remove once it has been in contact with surfaces/other items. To ensure even, thorough scenting of the articles turn/shake the jar occasionally.
- PLEASE REMOVE COTTON WOOL PAD AND REPLACE LID SECURELY BACK ON TO JAR BEFORE TURNING/SHAKING
- Use gloves or tweezers when removing cotton wool pad and place pad, gun oil side up on a clean tissue or another cotton wool pad. After shaking, replace cotton wool pad into jar and secure the lid. Note also that articles should not fill any jar by more than 1/4.
- The scented articles will be ready for use after 7 days and for up to 4 weeks.

Distraction scents must be prepared in the following way:

- 1cm x 1cm - 2cm x 2cm clean blank unscented cardboard/cotton/fleece/velcro pieces to be placed into sealed plastic containers or lidded glass jars.
- 4cm x 4cm sections of dog bedding or toweling can be cut up or alternatively wrap an unused cotton wool pad, swab or velcro in a used towel or bedding for at least 24hrs before placing into a sealed plastic container or lidded glass jar.

- Dog odour scents should be prepared one or two days before the trial.

Notes

- The judge will decide and tell the competitors beforehand as to which 'distraction scents' they plan to use.
- The 'distraction' scents should be used as a single odour and not in a combination of another distraction scent.
- The same two 'distraction' scents can be used in all three searches (except vehicles).
- The 'distraction' scents should be placed in the search area at the same time as the 'Target scent' and hidden from view.
- It is better if someone other than the judge hides the 'distraction' scents to prevent any possible contamination.
- A 'distraction' scent must not be placed in the same item that contains a 'target' scent or within a distance of 1m 20cm on any axis from a 'target' scent or another 'distraction' scent.
